# OUR ENVIRONMENTAL COMMITMENT



In March we attended WHD.global, which is the main global event for cloud services and internet infrastructure where leaders come together to understand how digital technologies fit together to shape our future.





# THE .eu DOMAIN


#### TOTAL NUMBER OF .eu REGISTRATIONS AT MONTH'S END

During Q1 2017, 1 561 new IDN registrations were made.




# MULTI-YEAR REGISTRATIONS (MYRs)

# TOP 10 CENTR ccTLDs BASED ON REGISTRATIONS AS OF Q1 2017





Top growth countries Q1 2017 vs. Q4 2016



### MARKET SHARE OF TOP 10, TOP 100 AND TOP 500 REGISTRARS

The top 100 .eu accredited registrars manage about 87% of all registrations, which means that many registrars are small businesses. Compared to the previous year, the market share of the top 10, 100 and 500 registrars has decreased.
