



Country of registrant | Registrations based on citizenship: 19 591 (266% yearly growth)






Registrar market share

Achievements

EURid in 2021

EURid suspended over 81 000 Brexit-related domain names, which were no longer compliant with the .eu regulatory framework.

EURid and the Global Cyber Alliance joined forces for the **Domain Trust project**, with the mutual goal of improving the security of the cyber ecosystem.

EURid planted **1000 trees** to celebrate its fifteenth anniversary and contribute to a greener future.

.eu registrations eligibility was extended to citizens of Iceland, Liechtenstein and Norway

regardless of their place of residency.

EURid launched the second edition of the **SAFEonLINE Art Competition** to award secondary school students for the best visual designs revolving around cybersecurity and Internet safety.

The Dynamic Coalition on Data and Trust published its 2021 Action Plan with the aim of being engaged in policy discussions and showcasing relevant research that explores linkages between data, information and trust.

Q1

.eu TLD marked its fifteenth year of providing a great service to great stakeholders. With 3.6 million domain names registered, EURid will continue to consolidate operations, simplify processes and add value to the .eu domain name.

EURid was successfully **re-certified by EMAS**, which means registration under the verified European environmental management standard is confirmed until 2023.

EURid's public website underwent an in-depth assessment of its accessibility and achieved **accessibility level AA: optimal compliance.**

.eu Academy worked on shaping the **Digital Europe** of tomorrow, with tailored webinars carried out in collaboration with Europol, EUIPO, the Dutch Government and Pisa University.

Q4

EURid`s initiatives during the **European Code Week** project included several workshops held in Belgium, Sweden, Czech Republic and Italy on robotics and coding.

EURid announced that it has again been selected by the European Commission to continue as the .eu TLD's registry manager through to October 2027.

EURid announced the winners of the eight **.eu Web Awards** during a magnificent gala held in Taormina, Sicily.
