




Q3 2023

In Q3 2023, 157,962 new registrations were recorded, contributing to a total of 3,716,776 .eu domain name registrations at the end of the quarter. Cyprus led in relative portfolio growth with 8.2%, followed by Portugal with 4.8% and Hungary with 2%.

In addition, EURid revealed the 10 winners of the SAFEonLiNE art competition, published its 2023 Environmental Statement, revealed the 15 finalists of the 10th annual .eu Web Awards, and announced the date for the second .eu day, which will be held on 16 November in Brussels, Belgium.

JULY 2023

EURid revealed the 10 winners of the 2023 SAFEonLINE art competition, which received an overwhelming response of 103 innovative artworks from European high school students, focusing on the theme of online safety.


SEPT **2023**

With EURid's collaboration, the first Top-Level Domain ISAC website goes live, sharing threat intelligence and enhancing cybersecurity capabilities across Europe.


An informative article by Alastair Gill revealed how **EURid supported the multi-stakeholder model during this year's EuroDIG** in Finland, and beyond.

INTERNATIONALISED DOMAIN NAMES (IDNS)




MULTI-YEAR REGISTRATIONS (MYRS)





Top growth countries Q1 2023 vs. Q3 2023 with over 1000 registrations


